## **NOTICE DISCIPLINARY ACTION In respect of Sri Paramananda Saikia**

It is to notify all concerned that a joint reply to the Show Cause Notice was submitted by Sri Paramananda Saikia and Parves Musharaf Hussain on 05.09.2024. On perusal of the reply, it is found that -

- 1) You failed to give the explanations of all the charges leveled against you.
- 2) You had submitted an application on 31.08.2024 at 2.50 PM, seeking permission to re-organize the Freshmen Social, 2024-25. So again you have crossed the limit to misled students and College Authority.
- 3) You captured the stage & did not allow even to welcome the new comer students of the College. The other functions like introduction with newcomers, cultural programme couldn't be held only because of few students led by you.
- 4) After issuing notice and repeated communications, on 22.08.2024, you have finally submitted the expenditure statement of College Week with justifications for excess expenditure in some heads.
- 5) On 31.08.2024, at around 1.00 PM, Principal i/c along with other teachers came to the stage requested you to vacate the stage so that programme could be started and gave assurance in the stage in microphone & in front of all students to release your remaining amount of College Week by coming Tuesday i.e. 03.09.2024, but you paid no heed neither to the Principal i/c nor to the other teachers and did not allow the programme.
- 6) Not a single programme you had allowed to be held and now in your reply you have stated **"The programme went ahead. Each and everyone of us and present student enjoyed the freshmen programme....."** It is really shocking, what a double - standard role played by you, on the one hand submitting the application to re-organize freshmen social and on the other hand stating that the programme went ahead and all student enjoyed the freshmen programme.

In view of all these, while considering the reply to the Show Cause Notice, the College Authority found the reply to the Show Cause Notice as non - satisfactory, self - contradictory & baseless that was submitted by **Sri Paramananda Saikia**, a student of **LL.B 5<sup>th</sup> Semester bearing Class**
