The word "Tez" in Assamese means blood, and the word "pur" means a place, a city or a town, thus meaning, a city of blood; the blood that sustains life.



LOCATION. NATURAL BEAUTY AND CONNECTIVITY

Tezpur is located on the north bank of the mighty Brahmaputra. It is said to be the most beautiful town of the Brahmaputra Valley. Having three small hills on its southern flank, and a number of natural drains called "Hola', Tezpur is naturally protected from the twin problems of flood and water logging which the other towns of Assam have to face. The famous Kaziranga National Park is situated to its south east, and the Nameri National Park a few kilometers to its north in addition to its own adjacent hills like the Agnigarh, Bhairabpad, Bamunipahar, Ouguri and Bhomoraguri hillocks together with a number of beautiful parks within its heart, make Tezpur a truly evergreen and the most beautiful town in the entire Assam valley.

Tezpur is well connected with the rest of the State and the country by road, rail and air, National Highway 15 and the National Highway No. 37 (A) connects Tezpur with all major cities and towns of Assam and of the entire North-East. Tezpur is considered as the doorstep of our beautiful neighbouring State, Arunachal Pradesh. The Districts of East Kameng, West Kameng, Tawang, Papumpare, Lower Subansiri, East Siang and West Slang of Arunachal Pradesh are easily accessible from Tezpur by road communication.

Justice Iqbal Ahmed Ansari Hon'ble Chief Justice (Retd),Patna High Court Former Judge of Gauhati High Court

Born on 29th October 1954, at Tezpur (Assam). He did B. Sc. From Darrang College, Tezpur. He was a good debater and is awardee of the trophy for best literary competitor of his college. He did graduation in law from Tezpur Law College, where his father, a bar-at-law himself, was the founder Principal. Handled both civil as well as criminal matters. Remained deeply involved with the activities of All Assam Lawyers Association and many other Socio-cultural and educational bodies. He was the President of Tezpur Lion's Club. He also served as Executive Chairman of State Legal Services Auhority in Arunachal Pradesh and Nagaland and has accordingly performed the duty of legal awareness.

He is a life member of Indian Institute of Public Administration, was selected into Grade-I of Assam Judicial Service in April'1991. He also served as District & Sessions Judge and he was the President of Assam Judicial Service Association. He was elevated to Gauhati High Court on 4th March,2004.

In July 2016 he became the Chief Justice of Patna High Court and retired in October 2016.On 1ST August,2017 he was appointed as Chairperson of Punjab State Human Rights Commission.



Admission Rules

A. Introduction to B.A LL.B (5 years)

Bar Council of India Rules and Gauhati University Regulation

There shall be a 5yr. BALL B of 10 (ten) semesters, spreading over 5 academic years, with Choice Based Credit and Grading System (CBCGS) leading to the Award of BA LL.B degree for the purpose of enrolment as advocates under Advocates Act, 1961.

Eligibility for Admission

An applicant who has successfully completed Senior Secondary School course ('10+2') or equivalent (such as 11+1, 'A' level in Senior School Leaving Certificate Course) from a recognized university of India or outside or from a Senior Secondary Board or equivalent, constituted or recognized by the Union or by the State Govt., may apply for admission into the course.

Provided that applicants who have obtained 10+2 Higher Secondary Pass Certificate or equivalent certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission in the integrated five year law course.

Age on Admission

There will be no age bar for taking admission.

Admission Procedure:

Admission shall be made strictly on merit by the College Admission Committee. The merit list, shall be published in the office Notice Board of the College and College Website. Any selected student who fails to pay his/her admission fee and other charges by the date fixed for such payment shall forfeit his/her claim for admission.

Prohibition to Register in Two or More Regular Course of Study:

No student of the 5 yr. BALL B course shall be allowed to register simultaneously with any other graduate, postgraduate, certificate or diploma courses run by the same or any other university or institute for academic or professional learning.

Production of NOC (No Objection Certificate)

Any service holder who wants to pursue B.A LLB (5 years) has to submit a NOC from the Employer within 15 days from the date of admission failing which the seat shall be forfeited.

Minimum Marks in Qualifying. Examination for Admission:

As per stipulation of the Bar Council of India the minimum percentage of marks not below 45% of the total marks in case of General category applicants & 40% for SC/ST & 42% for OBC applicants, to be obtained in the qualifying examination, i.e, in Higher Secondary (HS)/10+2 or equivalent examination.

Provided that such a minimum qualifying mark shall shall not automatically entitle a person to get admission in the college, but shall only entitle the person concerned to fulfill other criteria notified by the college concerned or by the government concerned, from time to time, for admission.

Time Limit for Clearing the Degree:

A candidate shall be required to clear his/her 5 year integrated law degree course within a period of 8 (eight) years from the date of his/her admission in the 1st Semester of the Course.

Reservation policy:

Reservation policy of the Govt. in the category of physically handicapped and candidates having extra-curricular and co-curricular activities shall be followed while selecting the candidate. As per existing policy 7% (seven percent) of the total seats will be reserved for the applicant from schedule cast (SC), 10% (ten percent) for applicants from scheduled tribe-plains (ST-P), 5% (five percent) for applicants from schedule tribes-hills (ST-H). The reservation policy would be revised from 15% to 27% as per notification issued by Directorate of Higher Education, Govt. of Assam (Reference no. DHE/EG/misc./79/2023/24 dated 20/07/2023) as applicable for Non-Creamy Layer candidates of OBC/MOBC community.

B. Introduction to LL.B (3 years)

Bar Council of India Rules and Gauhati University Regulation

There shall be a 3yr. Law Degree Course of 6 (six) semesters, spreading over 3 academic years, with Choice Based Credit and Grading System (CBCGS) leading to the Award of LL.B. degree.

Eligibility for Admission:

An applicant who has graduated in any discipline of knowledge from a university established by an Act of Parliament or by a State legislature or from an equivalent national institution recognized as a deemed to be University or from a foreign university recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three year Law degree course leading to conferment of LL.B degree on successful completion of the regular course.

The Degree Certificate in distance or correspondence method shall also be considered eligible for admission in the 3yr law degree course.

Age on Admission

There will be no age bar for taking admission.

Admission Procedure:

Admission shall be made strictly on merit by the College Admission Committee. The merit list, shall be published in the office Notice Board and College Website. Any selected student who fails to pay his/her admission fee and other charges by the date fixed for such payment shall forfeit his/her claim for admission.

Prohibition to Register in Two or More Regular Course of Study:

No student of the 3yr, law course shall be allowed to register simultaneously with any other graduate, postgraduate, certificate or diploma courses run by the same or any other university or institute for academic or professional learning.

Production of NOC (No Objection Certificate):

Any service holder who wants to pursue LL.B (3years) has to submit a NOC from the Employer within 15 days from the date of admission failing which the seat shall be forfeited.

Minimum Marks in Qualifying Examination for Admission:

As per stipulation of the Bar Council of India the minimum percentage of marks not below 45% of the total marks in case of General category, 40% for SC/ST & 42 % for OBC to be obtained in the qualifying examination, i.e, in First Degree Examination in any discipline.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission in the college, but shall only entitle the person concerned to fulfill other criteria notified by the college concerned or by the government concerned, from time to time, for admission.

Time Limit for Clearing the Degree:

A candidate shall be required to clear his/her 3 year law degree course within a period of 5 (five) years from the date of his/her admission in the 1st Semester of the Course.

Reservation policy:

Reservation policy of the Govt. in the category of physically handicapped and candidates having extracurricular and co-curricular activities shall be followed while selecting the candidate. As per existing policy 7% (seven percent) of the total seats will be reserved for the applicant from schedule cast (SC), 10% (ten percent) for applicants from scheduled tribe-plains (ST-P), 5% (five percent) for applicants from schedule tribes-hills (ST-H). The reservation policy would be revised from 15% to 27% as per notification issued by Directorate of Higher Education, Govt. of Assam (Reference no. DHE/EG/misc./79/2023/24 dated 20/07/2023) as applicable for Non-Creamy Layer candidates of OBC/MOBC community.

Important Information regarding forfeiture of seat:

It is to be notified to all BALLB/LLB candidates that---

- 1. If the candidate after taking admission fails to attend classes after the commencement of regular classes within 10 days and the valid reason along with evidence is unreported to the Principal, then his/her seat will be automatically given to the next qualifying candidate.
- 2. No admission fee will be refunded.

Documents to be enclosed/uploaded for BA LLB & LL.B:

- 1. H.S.LC-Admit Card, Mark sheet, Pass Certificate.
- 2. H.S.S.LC-Mark sheet, Pass Certificate.
- 3. Caste Certificate (if any).
- 4. Non Creamy Layer Certificate for OBC/MOBC Candidates
- 5. Passport Photo
- 6. Aadhaar Card
- 7. NOC from employers (Only for service Holder)
- 8. B.A/B.Com/B.Sc, etc.-Marksheet,Pass Certificate (applicable in case of LL.B Candidates)
- 9. G.U Registration/Migration Certificate.
- 10. Other Certificates(if any)

Mandatory Rules for Appearing Semester Examination:

1. No student shall be allowed to appear in the end semester examination in a paper if he/she has not attended minimum of 70% of the classes held in the paper concerned including in tutorials, Seminar, Viva, Moot Court exercises, practical training etc. conducted in respect of that paper.

If a student for any exceptional reasons fail to attend 70% of the classes held in any paper, the Principal of the college may allow him/her to take the examination if he/she attended at least 65% of the classes held in the paper concerned and attended 70% of classes in all the papers taken together. Provided a list of such students allowed to take examination, with reasons recorded, be forwarded to BCI.

2. A candidate must secure at least 45% of marks (i.e. 9 marks out of 20) in the Internal Assessment of each of the papers in which there is provision for internal assessment.

Academic Standards and Courses to be Studied:

Medium of Instruction: English shall be the medium of instruction in 3years LL.B course and 5 years B.A.LL.B Course.

Disciplinary, Anti Ragging and Penal Provision:

- 1) Every student shall maintain high standard of peace and tranquility, ideal conduct, cleanliness and discipline in class room and within the college campus.
- 2) No students shall shout and scream or commit acts of misbehavior with his/her fellow students and employees of the college.

- 3) Ragging in any form is strictly prohibited and would attract severe disciplinary action including the punishment of expulsion from the college.
- 4) Obscene and indecent behavior shall invite strict disciplinary action including expulsion from the college.
- 5) Sexual harassment or any practice derogatory to human dignity and personal privacy are strictly prohibited. Anyone found indulging in such act would be placed before the anti-ragging and disciplinary committee for taking Immediate & appropriate strong action.
- 6) Library is maintained and managed in accordance with the rules framed for the library. It is mandatory for all students to strictly adhere to the rules. Non-compliance shall meet strong disciplinary action.

These disciplinary regulations are deemed to be known to all students of the college.

N.B.- For any matter not covered under this regulation for semester system, the existing University Rules and the Gauhati University Act, 1947 (as amended up-to date) shall be applicable.

Examination Rules

- 1) Only pen, pencil, eraser, scale, transparent water bottle, admit card and registration card are allowed to bring to the examination hall.
- 2) Mobile phones, smart watches, bluetooth or any other electronic devices are strictly prohibited and such materials are to keep outside the exam hall at their own risk.
- 3) Candidates are required to sign their names on the Roll Sheets during the examination. College will not be responsible for non-entry of the name of any candidate.
- 4) If loose sheets, manuscripts or printed are found inside an answer script at any time during examination and if contents partly/ exactly tally with the answers, it shall be deemed as an act of malpractice and such a candidate shall be liable to expulsion and shall not be allowed to continue the examinations.
- 5) Candidates consulting with one another, copying from others answer scripts, looking at others papers, trying to receive help from others or somehow suspected to be attempting unfair means will be warned by putting "W" by the Invigilator.
- 6) Violence, arguments, threatening or intimidating any invigilator or officers conducting the examination shall be liable to expulsion.
- 7) No Candidate is allowed to enter the Examination Hall after 30 minutes of commencement of Exam and to leave the Examination Hall before 1 hour of commencement of the Examination.

DRESS CODE

The students of Tezpur Law College will have to follow dress code while attending the Theory classes as well as while attending the prescribed clinical classes such as Moot Court, visit of Lawyer's Chamber, Civil and Criminal Courts, Lok-Adalats, Legal aid Camps, Clinic and Internship etc. The students are expected to have two sets of the prescribed dresses. (Uniform)

FOR MALE STUDENTS

Summer: White full Sleeve Shirt, Black Pant, Black neck-tie, Black Shoes and Socks.

Winter: White full Sleeve Shirt, Black Pant, Black neck-tie and Black Blazer.

FOR FEMALE STUDENTS

Summer: White Kurta (with full sleeve) with Black Pyjama, Black Dupatta, Black Shoes and Socks.

Or, White Shirt, Black Pant, Black neck-tle, Black Shoes and Socks.

Winter: Black Blazer, White Kurta (using full sleeve) with Black Pyjama, Black Duppatta, Black Shoes and Socks and Black neck-tie.

(N.B. Jeans, Sporting, T-Shirts etc. are strictly prohibited in both Theory and Practical classes including internship.)
